The Gibbes Museum of Art is the only accredited art museum in the city of Charleston with a long history of presenting outstanding, award-winning exhibitions and scholarship for the state of South Carolina, its residents, and visitors. Additionally, the Gibbes contributes more than \$120 million to the State's creative and tourism economies, it is one of the oldest, largest, and most significant public, cultural institutions in the State, and the oldest art museum building in the Southeast.

In 2019, the Gibbes received the prestigious SC Governor's Award for the Arts recognizing the organization for outstanding achievement and contributions to the arts and the Chamber of Commerce's Beacon Award given to a structure that elevates aesthetics and improves quality of life for the region. It has also been named the best museum in South Carolina by USA Today, and one of the top museums in Charleston by the Travel Channel. Today, the Gibbes has garnered numerous accolades since reopening and during the pandemic for enhancing cultural tourism and contributing to its economic resiliency and growth.

This funding to support capital improvements at the Gibbes will further enhance cultural tourism and contribute to its economic resiliency and growth.


